PARTICIPANT ASSUMPTION OF RISK AND RELEASE OF LIABILITY

In consideration of being permitted to participate in the Potter's Ranch Ropes Course program, its related events and activities, or any part thereof, _____, the undersigned, appreciate(s), acknowledge(s), and agree(s) that:

I represent that I (or if a minor, the participant) have been advised to and have had the opportunity to consult with a family physician prior to engaging in the activity contemplated by the Potter's Ranch ropes course. I further represent that I (or the minor) am/is physically capable of performing the rope course's vigorous and strenuous physical activity and that I have no physical ailments, conditions, disease, or injuries, which inhibit or otherwise contraindicate my (or the minor child's) participation. I further recognize the importance of a good physical condition and acknowledge that Potter's Ranch, the Robert J. Lightner Foundation, Inc., and its agents, and employees will rely upon this representation in allowing me to participate in the Potter's Ranch ropes course.

1. The risk of injury from participation in the activities involved in this program is significant, including the potential for permanent disability, paralysis and/or death, and while particular rules, equipment, staff attention and personal discipline may reduce this risk, the risk of serious injury does exist;

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and I assume full responsibility for my participation;

3. I willingly agree to comply with the stated and customary terms and conditions for participation and will abide by the program's rules of personal conduct. If, however, I observe any unusual significant hazard during my presence or participation in the program, I will immediately remove myself from participation and bring such hazard to the attention of the nearest representative of Potter's Ranch and

4. For myself and on behalf of my heirs, assigns, personal representatives and next of kin, I HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS (POTTER'S RANCH AND THE ROBERT J. LIGHTNER FOUNDATION, INC., its trustees, officers, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the program or event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or other loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, OR IN ANY WAY ARISING, EITHER DIRECTLY OR INDIRECTLY, FROM PARTICIPATION IN THE POTTER'S RANCH ROPES COURSE, to the fullest extent permitted by law.
